Subject:-Scheme guidelines on Pradhan Mantri Paridhan Rojgar Protsahan Yojana (PMPRPY)-rgd

The undersigned is directed to state that the guidelines on PMPRPY were circulated vide O.M. of even number dated 11<sup>th</sup> August, 2016. Subsequently the Cabinet has approved extension of PMPRPY to made-ups sector of textiles. Accordingly the addendum to the guidelines is enclosed herewith. It shall come into force from 16<sup>th</sup> March, 2017. This addendum is to be read with the Pradhan Mantri Rojgar Protsahan Yojna scheme guidelines issued on 9<sup>th</sup> August, 2016 by Ministry of Labour & Employment read with the modification made on 23<sup>rd</sup> February, 2017 to the said scheme. EPFO will make necessary arrangements for extending PMPRPY to made-ups. The scheme may be popularized among industry for wide participation and coverage

## Pradhan Mantri Paridhan Rojgar Protsahan Yojana (PMPRPY)

In pursuance of the cabinet decision to extend PMPRPY to made-ups, the Ministry of Textiles makes the following additions to the scheme guidelines circulated earlier on 11<sup>th</sup> August 2016.

2. Under Item D Scheme Eligibility, Para 4 the following NIC Codes shall be added with effect from 11<sup>th</sup> March 2017.

### **NIC codes: 1392 Manufacture of made-ups textile articles, except apparel**

13921: Manufacture of curtains, bed covers and furnishings.

13922: Manufacture of crocheted made up textile goods except apparel

13923: Manufacture of mosquito nets

13925: Manufacture of tarpaulin

13926: Manufacture of blankets

13929: Manufacture of other made-up textile articles, except apparel n.e.c

This class excludes:

-manufacture of textile articles for technical use.
