- (c) The firm should have a minimum of three years experience in supplying these items to the Government Ministries / Departments, PSUs, Statutory / Autonomous Bodies etc.
- (d) The firm should have a valid PAN number.
- (e) The firm should have minimum annual turnover of Rs. 20 lakh during each of the last three years.
- (f) The firm should be a authorized supplier/reseller of the brand for which bid has been submitted. Authorisation letter in this regard should be enclosed with bid.
- (g) The bidding firms are required to submit Technical Bids and Financial Bids. The Financial Bids of only those firms shall be opened who qualify technically.
- (h) The firms should quote unconditional rates strictly as per list of items. There should be no cutting/overwriting in the bids.
