2. The Cotton Advisory Board (CAB) as reconstituted above, will be effective for a period of two years w.e.f. 1st January, 2013.

3. The Board will advise the Government generally on matters pertaining to production, consumption and marketing of cotton.

4. The Cotton Advisory Board, through a consultative process will seek inputs from Cotton Textiles Mill industry, the cotton growers and cotton traders. The Consultative Committee shall meet prior to the formal meeting of the Cotton Advisory Board. The inputs of the Consultative Committee recommendations shall be considered by the CAB. The Consultative Committee of the CAB will have the following composition:
