In the event of designated CPIOs/AAs availing leave or transferred or retired or the post is lying vacant for any other reason, the Link Officer or newly joined officer in place of him/her or the chain of officers down the line would act as CPIOs/AAs to fulfil the duties bestowed under the RTI Act and would be fully responsible for implementing the provisions of the RTI Act in respect of their section/charge.
