#### Monthly Summary to the Cabinet for the Month of July, 2022

1. Important policy: NIL

#### 2. Important Achievements:

- I. All India arrival of seed cotton was around 1.30 lakh bales. Cumulative arrival of cotton this cotton season from October 2021 to July 2022 has been 301.97 lakh bales. This is approx. 13% less as compared to corresponding period of last year. Since the price of cotton in the market is ruling above MSP, Cotton Corporation of India (CCI) has not procured cotton under MSP operations during July, 2022.
- II. In order to promote Handlooms in domestic and overseas market, Handloom Export Promotion Council, Chennai organized one International Event: India Tex Trend Fair, Tokyo, Japan during in the month of July, 2022.

Under the **Weavers' Mudra Scheme**, in July 2022, 591 number of MUDRA Loans were sanctioned.

- III. An Integrated Development & Promotion of Handicrafts (IDPH) Project (Telangana) sanctioned in the year 2016-17 with a total project cost of Rs. 1320.72 Lakhs for the promotion and development of Handicrafts in the State of Telangana. It is implemented by Telangana State handicrafts Development Corporation (TSHDC). Same has been completed successfully with the following outcomes:
  - 10 Design Development Workshops, 03 Integrated Design Development Projects, 18 Technical Training Programme, 4 Crafts Awareness Programme and 2 Craft Demonstration Programmes have been conducted.
  - 2 Exhibitions, 2 Crafts bazars, 1 Emporium and 4 Common Facility Centers (CFCs) have been set up.
  - 365 modern toolkits have been distributed to artisans.
  - Publicity, Brand promotion and web marketing have been undertaken for promotion of crafts of Telangana.
- IV. Under **Production Linked Incentive (PLI) Scheme,** 64 applicants were selected and letters of approval were sent to 44 selected participants in July, 2022. Investment to the tune of Rs. 700 crore approximately has been made. Further, a meeting under the Chairmanship of Secretary (Textiles) was held on 10.06.2022 for reviewing the PLI Scheme for Textiles and discussing way forward for Round II of PLI. A meeting was also held under the chairmanship of Secretary (Textiles) on 13.7.2022 regarding PLI-II.

- V. A meeting of Empowered Committee (EC) under **Samarth Scheme for Capacity Building in Textile Sector** under the Chairmanship of Secretary (Textiles) was held on 25.07.2022 in hybrid mode. EC has allocated a training target of 19,234 beneficiaries to 5 newly empanelled agencies and 12 existing agencies.
- VI. 7<sup>th</sup> meeting of Inter Ministerial Steering Committee (IMSC) under **Amended Technology Upgradation Fund Scheme (ATUFS)** chaired by Hon'ble
