### Monthly Summary to the Cabinet for the Month of August, 2022

1. Important policy : NIL

2. Important Achievements:

- I. All India arrival of seed cotton was around 5.50 lakh bales. Cumulative arrival of cotton, this season from October 2021 to August 2022 has been 307.47 lakh bales. This is approx. 13% less as compared to corresponding period of last year. Since the price of cotton in the market is ruling above MSP, **Cotton Corporation of India (CCI)** has not procured cotton under MSP operations during August, 2022.
- II. 8th **National Handloom Day** was celebrated by Ministry of Textiles on 7<sup>th</sup> August, 2022 at The Hotel Ashok, New Delhi. During the function, Hon'ble Minister of Textiles and Hon'ble Minister of State for Textiles conferred Sant Kabir Awards and National Awards to 85 handloom weavers for the year 2017, 2018, and 2019 for their excellence and remarkable contribution in the field of handloom sector. An exclusive expo was also organized at Handloom Haat, Janpath, New Delhi from 05-08-2022 to 11-08-2022 for these awardees to showcase and sell their exclusive products.
  - Functions befitting the occasion were simultaneously organized in all the subordinate offices of Development Commissioner (Handlooms) viz. Weavers Service Centre(WSCs) and National Handloom Development Corporation with the following promotional activities on handloom:
    - Dissemination of major initiatives for development of handloom sector: Cluster Development Programme, India Handloom Brand, Handloom Mark, MUDRA Scheme, Insurance Scheme, e-commerce, e-Dhaga, GI etc.
    - Presentation of local success stories
    - Interaction with weavers
    - Exhibition of Designs/ Samples & Products of WSCs
    - Dissemination of information through DRCs

Exclusive handloom expo was also organized at Janakpuri Haat, Janakpuri, Delhi from 05-08-2022 to 16-08-2022 during 8<sup>th</sup> National Handloom Day by inviting handloom weavers to sell and showcase their handloom products.

Handloom Export Promotion Council, Chennai organized two Domestic marketing events - Handloom Sourcing Show at Bhagalpur, Bihar & Bargarh, Odisha. Special events titled 'Law of Woven Dreams' were held at London & Madrid in Associate with our High Commission/ Embassy in UK & Spain curated display of 75 handloom products representing all regions of the country was organized. Workshops were also organized at both these places. Live loom demonstration was organized. The events were well received in both the countries.

Under the **Weavers' Mudra Scheme**, in August 2022, 852 number of MUDRA Loans were sanctioned.
