

The tenders will be opened on the same date i.e., 23<sup>rd</sup> February, 2017 at 03:30 P.M. in Room No. 29 B, Udyog Bhawan, New Delhi-110011. The tenders may be accompanied by the earnest money of Rs. 5000 /- (Rupees five thousands only) in the shape of Demand Draft/Pay Order in favour of DDO, Ministry of Textiles, New Delhi, failing which tender will not be entertained.

**Note: The Contractor can visit the site on 20<sup>th</sup> February, 2017 from 11:00am to 01:00pm with the Section Officer and Assistant in charge for the inspection.**

3. The following terms and conditions may be kept in view while submitting the bids:-

- (i) The firm should be authorized suppliers/resellers/agency of the brand for which bids has been quoted. Authorization letter in this regard should be enclosed with bids.
- (ii) Proof of PAN/TIN No. should be enclosed.
- (iii) Proof of Central Sales Tax/Registration under Delhi Value added Tax Act should be enclosed.
- (iv) Overcutting/corrections or incomplete(blank) quoting of rates would result in rejection of tenders.
- (v) Ministry reserves the right to accept or reject any/all tenders without assigning any reason, whatsoever.
- (vi) The agency has to undertake the work in package mode i.e., dismantling of compactor in Room No. 541, Udyog Bhawan, transport & re-assembly at Jam Nagar House.
- (vii) The agency has to transport the compactor in good condition & may be responsible for any damage to it at any stage.
