Ministry of Textiles invites sealed bids for disposal of condemned/obsolete unserviceable items (list attached) on as is where is basis.

You are requested to submit your bid for these items along with a demand draft of Rs.5000/-(Rs. five thousand only) as Earnest Money, drawn in favour of DDO, Ministry of Textiles, latest by the 7<sup>th</sup> November, 2016 by 3.00 PM in sealed cover addressed to the undersigned i.e. Under Secretary (Admn.), Ministry of Textiles, Room No.29-B, Udyog Bhawan, New Delhi-11. Bids received after stipulated date/time shall not be entertained. The rates must be quoted lump-sum basis. Rates quoted partly will not be accepted.

3. Interested parties may contact for inspection of the items on all working days upto 28<sup>th</sup> October, 2016 between 3.30 PM and 4.00 PM.

4. The bids will be opened in the presence of the bidders on 7<sup>th</sup> November, 2016 at 3.15 PM in Room No.29-B, Udyog Bhawan, New Delhi. The bidder will be selected on the basis of the highest bid. The successful bidder will be required to deposit the full amount in cash or submit a Demand Draft in favour of the DDO, Ministry of Textiles within three working days from the date of acceptance of bid. The items must be removed within three days from date of deposit of money.

5. The Ministry reserves the right of rejecting any or all bids without assigning any reason thereof at any time. The earnest money Demand Draft will be returned to the unsuccessful bidders immediately after finalization of bid. In the event of the successful bidder failing to submit the Demand Draft for the entire amount of bid and to remove the items within the stipulated period, his bid will be rejected and his earnest money deposit of Rs. 5000/-(Rupees five thousand only) will stand forfeited.
