2. The scope of work for empaneled access auditors includes:
  - i. Accessibility audits of websites, including but not limited to their designing, ease of navigation, usage of visual indicators, contrast and color, availability of text alternatives for image for screen readers etc. to ensure compliance with accessibility standards and guidelines notified under Rule 15 of the RPwD Rules.
  - ii. Documenting and reporting on the status of accessibility features on website.
  - iii. Providing detailed reports highlighting areas of non-compliance and taking corrective measures.
  - iv. Conduct training sessions or workshops for stakeholders involved in design, construction and maintenance of web applications to raise awareness about accessibility requirements
  - v. Monitoring and evaluating the implementation of recommended measures to ensure that they are effectively incorporated and continue to meet web accessibility standards.
  - vi. Staying updated on changes in web accessibility standards and regulations through continuous professional development.
